

**AGREEMENT**

**WITNESSETH**

Whereas, [REDACTED] has in its employment a teacher certified by the Kentucky Department of Education to teach hearing impaired students; and

Whereas, [REDACTED] has hearing impaired students that need to obtain instruction from a teacher certified to teach such students; and

Now, therefore, it is agreed as follows:

Whereas, [REDACTED] and [REDACTED] have agreed upon a plan to share the instructional services of Marshall's teacher for its hearing impaired students.  
1. Purpose of Agreement. The purpose of this document is to confirm an agreement between Marshall and Hopkins relative to those services to be provided to Hopkins by "EMPLOYEE NAME" who is employed by "DISTRICT NAME" as a teacher for hearing impaired students. "EMPLOYEE NAME" is a certified employee with a specialization in the teaching of hearing impaired students. "DISTRICT NAME" will perform professional duties for "SCHOOL NAME" two (2) consecutive days per week for the school year commencing August 5, 2016, and ending June 30, 2017, for a minimum of seventy-four (74) days of the one hundred eighty-six (186) day school calendar in effect for this year.

2. Duties: "SCHOOL NAME" duties for "DISCTRICT NAME" shall include but not be limited to providing instruction to the hearing impaired students enrolled in the "DISTRICT NAME" County schools all in accordance with that job description adopted by [REDACTED] for this position.

3. Compensation. [REDACTED] will reimburse [REDACTED] services at [REDACTED] at the rate of \$323.48 per day for a total of \$23,937.52 for the 2016-2017 school year. [REDACTED] will make its reimbursement payments to [REDACTED] in two (2) installments, one payment to be made in January of 2017 and the other in May of 2017. An invoice will be prepared by [REDACTED] and sent to [REDACTED] on or before the fifth day of the month in which a payment is due and [REDACTED] will return the required payment within thirty (30) days to [REDACTED] to the attention of [REDACTED], Finance Officer of [REDACTED] County Schools.

4. Expense Reimbursement. Any approved expenses [REDACTED] may incur in providing services to [REDACTED] under this agreement including but not limited to mileage on her personal vehicle are to be paid to [REDACTED] directly by [REDACTED], and [REDACTED] will have no responsibility for any of same. Any of [REDACTED] expenses subject to reimbursements under this agreement must be approved in advance by [REDACTED] Director of Special Education.

5. Evaluation. [REDACTED] and [REDACTED] shall each be responsible for evaluating [REDACTED] performance of her duties as a teacher in their District and the evaluations made by one District shall have no application in the other District.

6. Legal Effect. Nothing contained herein shall be construed as making [REDACTED] an employee of [REDACTED], for any purpose, it being fully understood by the parties that she will continue to be and remain a tenured employee of [REDACTED].

7. Effective Date. The effective date of this agreement shall be August 10, 2016.

8. Termination: The Contract shall terminate and be of no further force and effect should [redacted] cease to be a certified employee of [redacted]
