

AMENDMENT TO
PROFESSIONAL SERVICES AGREEMENT

THIS AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT (“Amendment”) is made and entered into by and between **BAPTIST HEALTH MEDICAL GROUP, INC.** (hereinafter referred to as "**Baptist**"); **WESTERN KENTUCKY REGIONAL MENTAL HEALTH AND MENTAL RETARDATION ADVISORY BOARD, INC. D/B/A FOUR RIVERS BEHAVIORAL HEALTH** (hereinafter referred to as "**Four Rivers**"); and **MCCRACKEN COUNTY PUBLIC SCHOOLS** (hereinafter referred to as "**School**").

WITNESSETH:

WHEREAS, Baptist is a Kentucky nonprofit corporation that provides professional medical services through its employed physicians and clinical practitioners in furtherance of Baptist’s charitable mission and with the expectation of providing a community benefit by fulfilling the health care needs of those served by Baptist; and

WHEREAS, School is a Kentucky public school system, which operates a multitude of preschool, elementary, middle, and high schools located throughout Paducah and West Paducah, Kentucky; and

WHEREAS, Four Rivers is a Kentucky nonprofit corporation that provides comprehensive, integrated mental health, substance abuse and mental retardation-developmental disability services in furtherance of Four Rivers’ charitable mission and with the expectation of providing a community benefit by fulfilling the health care needs of those served by Four Rivers; and

WHEREAS, School provides facilities to health care providers to maintain student health care clinics where School students have access to certain student health services, including but not limited to primary and behavioral health care services; and

WHEREAS, School, Four Rivers and Baptist entered into a professional services agreement in July of 2015 wherein School provided facilities for Baptist and Four Rivers to provide primary and behavioral health care services at McCracken County High School (“**MCHS**”) and for the benefit of the Heath School Community, which consists of Heath Elementary School, Heath Middle School and Open Campus (collectively referred to as “**Heath School**”) (the “**Agreement**”); and

WHEREAS, due to a delay in the construction process with the build out of the facilities, the parties desire to renew the Agreement for an additional one (1) year term so that Baptist and Four Rivers can continue to provide student health services to the students, faculty and families of School for the 2017-2018 school year.

NOW, THEREFORE, in consideration of these mutual covenants, the parties agree as follows:

1. The parties agree to replace Subsection A. of Section 7., **Term and Termination.** of the Agreement in its entirety as follows:

7. **Term and Termination.**

A. The term of this Agreement shall be for three (3) years from July _____, 2015 through July _____, 2018, unless otherwise terminated as provided under other provisions of this Agreement.

2. Except as provided in this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect. The parties agree that in the event of any conflict between the terms of this Amendment and the terms of the Agreement, the terms of this Amendment shall control.
